## Consignment Terms & Conditions Agreement

We are happy that you have chosen to work with *Next Time Consignment* and we will work hard to make this a rewarding process! Customers interested in consigning must fully complete the required information and agree to all terms stated by *Next Time Consignment* (NTC).

All consignment items must be **clean, free of dust, stains, and odor** and must be in a desirable condition and quality for resale. NTC will select from your items to consign. It is our goal to move your items as quickly as possible for the best possible price. To make this happen, we must consign and stock items that are most popular with our customers. *Please understand when we cannot accept an item.*

Bring smaller items in to the store, depending on inventory levels, limits may apply. For furniture and larger items, email or bring in a photo. Once NTC has agreed to accept items on consignment, the consignor will deliver the consigned items on a date and time as mutually agreed. When delivering furniture, please bring a long a helper, NTC staff may not be available to assist.

All items will be cataloged and numbered with a consignor ID number and stock number. All items accepted will be displayed for a full 90 days. Early pick-up of items will not be permitted.

NTC staff will price your items based on current supply and demand. We are happy to work with you on special pieces based on rarity, manufacturer, age, etc. It is our goal to maximize the selling price and move your items quickly.

NTC will automatically discount items 25% after 45 days. On occasion, at the discretion of NTC, we do accept rare special items that will not discount after 45 days, but **will** be subject to promotions. We require all consignors to participate in our Lay Away Program, periodic promotions, which commonly run, but not limited to a 10 - 20% discount.

NTC agrees to pay all consignors **50%** of the selling price of any **houseware** item. NTC agrees to pay consignors **60%** of the selling price of all furniture.

NTC will prepare a check for pick up for all items sold for the preceding month on the 10<sup>th</sup> day of the following month.  
**Consignor credits are available immediately for in store purchases.**

NTC will work hard to protect your items, but we are not responsible for any damage, theft or loss. All loading and unloading of items for consignments are at the risk of the consignor to include any possible personal injury.

At the end of the 90 day contract period, all unsold items must be picked up within 7 days. Any unclaimed item becomes the sole property of NTC and will be disposed of at our discretion.

**I have read and agree to all terms as stated above and understand this document is a legal, binding agreement between the consignor and consignee, Next Time Consignment.**
